

LiveBeyond Volunteer Waiver

PLEASE READ CAREFULLY

THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS

This Release and Waiver of Liability (the “Release”) executed on this ____ day of _____, 2017, by _____ (the “Volunteer”), in favor of Mobile Medical Disaster Relief (MMDR) a Tennessee Incorporated 501c3 DBA LiveBeyond located at 2110 Gladstone, Nashville 37211, and their officers, employees, and agents (collectively MMDR).

The Volunteer desires to work as a volunteer for MMDR and engage in the activities related to being a volunteer for **no compensation** (the “Activities”). The Volunteer understands that the Activities may include, without limitation, repairing and constructing residential buildings.

The Volunteer hereby freely, voluntarily, and without duress executes this release under the following terms:

Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless Mobile Medical Disaster Relief and its successors and assigns any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer’s Activities with The Nonprofit. Volunteer understands that this release discharges MMDR from any liability or claim that the Volunteer may have against MMDR with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer’s Activities with MMDR, whether caused by the negligence of MMDR or its officers, directors, employees, agents or otherwise. Volunteer also understands that MMDR does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Volunteer does hereby release and forever discharge MMDR from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer’s Activities with MMDR.

Assumption of the Risk. The Volunteer understands that Activities include work that may be hazardous to the Volunteer, including, but not limited to, residential repair and construction. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases MMDR from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance. . The Volunteer understands that he/she is responsible for carrying his/her own personal health insurance and that MMDR will not provide either health insurance coverage or workers compensation insurance for injuries that may be sustained in performing the Activities.

Other. The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that this Release shall be governed by and interpreted in accordance with the law of the State of Tennessee. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release which shall continue to be enforceable.
